#### 2019/176 PUBLIC PARTICIPATION

Councillors reported the following issues:-

Recent break in's at Whitchurch Cricket Club and in Saltwell Avenue, these have been reported to the Police.

The inadequate repairs of some of the pot holes in Staunton Lane.

The road surface in Church Road, which was resurfaced three years ago, are B&NES getting good value for the money they spend on this, as it needs totally resurfacing again.

Issues crossing the A37 to the Playpark, this has been brought up with B&NES on many occasions, a full review of the Woollard Lane junction was due to be carried out, including a safe crossing for pedestrians.

The overgrown hedge along the footpath in The Witheys.

The health and safety issues relating to the attenuation pond built on the new Bellway development, which is collecting rubbish and has no fencing around it.

# 2019/181 TO DISCUSS THE POSITION OF THE MILLENNIUM CLOCK AND AGREE THE WAY FORWARD

It was resolved that the Millennium Clock does not look right in its present location and that if it is left where it is, in the garden of a house, there may well be some legal ownership issues. Therefore it should be put somewhere else in the village, possibly in the Millennium Garden, if both clock faces can be seen from the road. The Clerk to obtain a quote from Western Power to install electricity in this location. The exact location will then be discussed again at the May meeting.

# 2019/182 TO RECEIVE UPDATES ON PROPOSED VILLAGE EVENTS BEING ORGANISED

It seems as though three organisations are planning to organise events for the August Bank holiday weekend, Whitchurch Cricket Club, Whitchurch & Pensford Royal British Legion and Whitehall Garden Centre. An update was given by a member of the cricket club, they are planning to arrange a band on the Saturday evening and possibly a Barn Dance over the weekend, but they are still discussing the actual details. It was agreed that they will liaise with the other two organisations.

### 2019/183 TO RECEIVE AN UPDATE ON THE COMMUNITY CLEAN UP

Another very successful clean up, around 30 volunteers including beavers, cubs and scouts from the 107<sup>th</sup> Bristol (Whitchurch) Scout Group, helping on the day. Around 25 bags of rubbish were collected from pavements, footpaths and open spaces around the village to make the area look clean and tidy.

Refreshments were provided in Whitchurch Community Centre, with homemade cakes donated by a local resident and much appreciated by the volunteers after all their hard work. Several residents suggested we do this again in September, the Scout Group happy to help again with this. A vote of thanks was given by the Chairman to all those who took part.

#### 2019/184 PLANNING AND TRAFFIC

#### a) To note the current Planning Application list.

The current Planning application listed in Appendix A, previously circulated to all Councillors was noted.

b) To agree a response to 19/01177/FUL – Ian Rideout, The Firs, Maggs Lane It was agreed to support this application and that Paul May will help with some wording to back up this support.

#### c) To ratify the response to Appeal Ref: APP/F0114/W/18/3216550

This response which had previously been circulated and agreed by all councillors was ratified. It was again agreed what an asset Jon Medlin is to the Council for his help with issues such as this.

#### d) To note the comments sent in to the JTP4 consultation.

The comments previously circulated, were noted. An invite to a meeting has been received from Steve George, Senior Planner, B&NES Council, in May, to receive an update on the JSP examination and progress with the B&NES Local Plan. It was agreed Weds 15<sup>th</sup> May is the best date for this meeting to take place and other specific details will be requested.

#### 2019/185 CLERKS REPORT

During the last month the following issues have been reported to B&NES:-

Fly tipping outside the playpark, 2 black bags left in Staunton Lane, which have been cleared. Pot holes in Staunton Lane, some were filled in but there are lots more yet to be dealt with, give way sign in Sleep Lane which has been damaged, blocked drain in Sleep Lane, which has been cleared.

B&NES are asking for feedback on amendments to the Planning Obligations Supplementary Planning Document with particular reference to Green Infrastructure and CiL.

The Clerk has written to Mitchells & Butler, who own the Maes Knoll Toby Carvery, asking if they will install Christmas Lights in the tree in the car park this year.

#### Correspondence

A request from Clutton Flower Show organiser for a vintage American car, does anyone know who has one of these in the village.

Maggs Lane will be closed from 8<sup>th</sup> April for a maximum of 4 days but it is anticipated the work will take 2 days.

Bristol City Council are consulting on the Bristol Local Plan Review details of which can be found on their website. Closing date for comments 24<sup>th</sup> May 2019.

#### 2019/186 ITEMS OF INTEREST FROM DISTRICT COUNCILLOR PAUL MAY BANES

Paul May explained that the public meeting in the village went well. He has carried out a survey to update the Neighbourhood Plan survey and to obtain up to date evidence. 100 replies have been received, the majority of replies received are against the road and bungalows are requested to be built in the village.

He has been speaking to the organisers of the Wrong Road Group encouraging them to send in objections to the JTP4.

He advised that the nursing home in the village has received a negative report from the CQC.

The Clean Air Zone in Bath has now been amended to redesign parts of the road network and not charge £9 for residents.

He thanked the village council members for all their support.

#### b) To receive an update on the pathways/roadway at the cemetery

Rachel Chandler has spoken with the contractor M Babbage & Son and has agreed a price £550.00 cheaper. A vote of thanks was given to Rachel for achieving this saving. The order has now been placed and the work will be carried out in June.

#### c) To consider a request for a full size grave for ashes casket interments

A letter was read out by the Clerk from a mother whose daughter has recently suddenly passed away, asking if she can purchase a grave to inter caskets of ashes for her daughter and other family members.

It was resolved that, although this is not standard practice, on this occasion and in the circumstances, the request will be granted.

#### d) To receive updates on the Playpark refurbishment

A working party meeting has been held where items of play equipment were viewed from other playparks, it was agreed to possibly extend the area for Play equipment with new fencing and gates surrounding this area. Early explorative proposals will be sought from Playpark providers including a MUGA (Multi-use games area). These will then be able to be consulted on before actual tenders are sought.

#### e) To receive an update on the allotment site

Five allotments plots became available this year and to date four of these have been taken with several people still interested in plots. So hopefully in the next couple of weeks they will all have been taken.

#### 2019/188 FINANCE

#### a) To note and agree the payment of accounts for April 2019

It was resolved the schedule of payments dated 3<sup>rd</sup> April 2019, as listed in Appendix B be paid.

#### b) To receive and agree any quotes received for: - painting the rusting gate, lighting on the cycle track, painting finger posts, refurbishing the Millennium Garden

Lee Gillam will paint the rusting gate on the cycle track, he has quoted £379.00 to paint the four fingerposts in the village, it was resolved to go ahead with this from CiL funds. The Clerk has been in touch with Sustran to find out their policy on lighting on cycle paths but has not received a reply to date. A plan and quotation for refurbishing the Millennium Garden has been received. It was resolved to investigate this further, meet with the contractor to discuss this in more detail.
