FIN/22/06 TO RECEIVE AN UPDATE ON CIL FUNDS HELD

The balance of CiL funds to date is £137,362.52 of which £12,527.32 is required to be spent by November 2022 but can only be spent on specific

thinas.

It was resolved to recommend that a beacon for the Queens Platinum

Jubilee is purchased using CiL funds, at a cost of £490.00 plus the gas

and a new bollard at the Playpark is installed.

Other suggestions made were – spot lights in the Millennium Garden, higher fencing on the allotment/playpark site, replace the netting on the allotment site, more Christmas lights on lamp posts, and new flower

baskets on lamp posts. More investigation is required to confirm CiL funds

can be used for these projects.

FIN/22/07 TO REVIEW THE RESERVES POLICY AND AGREE ANY AMENDMENTS

The Reserves Policy was reviewed, it was resolved no amendments are required this year, none of the amounts need to be changed at present. It will be reviewed again in January 2023.

FIN/22/08 TO NOTE THE RECOMMENDATION FROM THE PLAYFIELD/CEMETERY/ALLOTMENT COMMITTEE REGARDING INCREASING FEES FROM 1st APRIL 2022

The Playfield/Cemetery/Allotment Committee have agreed to recommend that the Cemetery fees are increased by 2% to be rounded up.

The Allotment fees will also increase from £25.00 to £30.00 for residents of Whitchurch Village and for any new non-residents to £40.00, with effect from 1st April 2022.

These recommendations were noted, it needs to be agreed when these fees will be reviewed again.

FIN/22/09 TO DISCUSS AND RECOMMEND CAPITAL EXPENDITURE FOR 2022/2023
