2023/07 TO DECLARE THAT THE COUNCIL MEETS THE CONDITIONS OF ELIGIBILITY FOR THE GENERAL POWER OF COMPETENCE

The Clerk explained what the General Power of Competence is. It is intended to give local authorities (including parish and town councils) wider powers to deliver more for their communities. The GPC will allow a council to do anything that individuals generally may do, except where other aspects of the law may forbid them from doing. It is intended to relieve councils of the need to find specific statutory powers to authorise their activities.

To be eligible to exercise the GPC a parish council must conform with the following:-

- at least two-thirds of the total number of councillors have been elected (at ordinary or by-election), not co-opted, at the meeting, the resolution is passed to confirm that the council is eligible.
- the council's clerk holds either
 Certificate in Local Council Administration (CILCA).
 Or level 4 qualification awarded by the University of Gloucestershire.

It was resolved that Whitchurch Village Council meets the conditions above and therefore it retains the ability to use the GPC until the annual meeting of the council in the next ordinary election year.
